### **President's Remarks**

The president, Donna Dyck provided a brief report. She spoke on the challenges the RPNAS faced over the past couple of years and thanked the Executive Director, Beverly Balaski for her efforts to streamline processes for the RPNAS.

### **Executive Director's Report**

The ED, Beverly Balaski spoke about reestablishing and improving the foundation and financial stability of the RPNAS and the work that is being done to improve processes.

The ED and president met with several stake holders to collaborate and develop initiatives to highlight the competencies of RPN's and the regulatory work of RPNAS

Research on Naloxone are complete with will be published once editing is finalized.

The ED spoke of strategic plans which include updating the website and database to make processes more accessible.

# 4. Financial Report

The financial report was presented by the chair, Darcy McIntyre A number of financial irregularities were noted in the 2018 financial year

- Budget was not well established or monitored
- Difficult to determine financial position of organization
- The association had been spending more than revenues collected
- Operating funds were put into long term investments. This gave the misperception that RPNAS had larger long-term reserves than it actually did
- Acceptable accounting practices were not being followed.

The ED notified council immediately upon discovery of the financial concerns. A finance committee was established in Sept 2018 in response to the concerns. Primary responsibility will be to provide oversight and communication to Council. ED and the RPNAS Accountant Consultant working to establish proper accounting and finance practices.

ED implemented policies and procedures for payment and expense practices.

### **Virtus Group Presentation**

Sheila Filion presented her report on the audited financial statements of the RPNAS. Virtus Group conducted the audit of the RPNAS for the 2018. Due to changes in staff, there was a significant amount

of information not available. Insufficient financial information made it very difficult to decipher actual costs due to lack of evidence and little information.

There is lack of information for management to explain the difference in revenue between 2017 and 2018, the difference is unexplainable. This has resulted in a qualified financial audit for the 2018 financial year.
